Chris McDaniel made a motion to approve the September 9, 2024, Monthly Board Meeting minutes. Andrew Woltmann 2<sup>nd</sup> motion. Motion carried.

#### **Road Maintenance**

Stop signs have been replaced but still no zebra signs by the culvert as of Friday on Richfield Wood, west of Polish.

Dave is trying to reach out to Enbridge as the culvert by Arpin Richfield/Richfield Wood is buried. Keith did do some filling on the northwest corner.

Dave spoke with the Township of Cameron about chip sealing. It is not in their budget for 2025 but when we do it, we should do it around the same time.

The owner of the property on the southeast corner of Richfield Drive and County Rd A is not responding so if the grass gets too high, the town will look into getting it cleaned up as it can be a road hazard.

Dave spoke with the Town of Arpin about the culvert on Arpin Richfield Road and they will not be pursuing the homeowner. To pull the culvert, it will cost around \$10,000 so Dave will talk with the Town of Arpin about splitting the cost.

Keith has potholes filled and will also be taking a chainsaw to cut some stumps/branches that are sticking out into the roadway. There will also be some grading done on gravel roads now that it has rained.

Dave will check with Randy on what we can do with the drilling area that was done previously on Richfield Dr, iust west of County Road A.

## **Snow Plowing**

The contract for snow plowing between the Town of Richfield and the Town of Wood was discussed.

Chris McDaniel made a motion to approve the 2024-2025 proposed snow plowing of \$85.00/hr per plow between the Town of Richfield and Town of Wood. Andrew Woltmann 2<sup>nd</sup> motion. Motion carried.

Paula will send out to Town of Wood Chairman to sign.

# Fire Department/EMR Report

Chief Josh Sabo reported the following for September 2024:

## Fire Calls for service since 9/9/24 – 5

1 in Richfield; burning complaint at 9119 Sth 80

4 automatic/mutual aid; semi fire-Town of Cameron; oven fire-Town of Marshfield, shed fire-Town of Arpin, lighting strike/house fire-Town of Arpin

<u>First Responder Calls since 9/9/24 - 0</u>; paged twice but canceled once and the other call was not in our jurisdiction

- 1. Calendar raffle sold 845 tickets, raised over \$17,000 for Thermal Imaging Camera upgrades
- 2. Ladder testing was completed and everything passed
- 3. Pump testing was completed and both trucks passed
- 4. Awarded a 50/50 DNR grant for \$17,000 for wildland/extrication gear, nomex hoods and water back cans. Our \$8,500 is accounted for in the FD 2025 budget.

Board approved for Josh to send out bill to property owner of the burning complaint.

#### **SCBA Purchase**

Loan was discussed. Andrew Woltmann made a motion to approve going forward with a loan for a 1-vear term of \$139,860.53. Chris McDaniel 2<sup>nd</sup> motion. Motion carried.
