#### **Township Loan**

## **Road Maintenance**

The maps have not been right as some roads are showing as half ours and half another municipality. We are looking into getting that fixed. Bridge estimates from Wood County were discussed. These bridges qualified for the 50/50 bridge aid. Arpin Richfield will be done yet this year. Next year we will look into having ditch cutting done more deeply because they are starting to get more brush. There is garbage on Bluff Dr. so Bob will go out this week to clean it up. We have an account set up with Farrell Equipment now & we finally got our supply of perma-patch so Chris will take care of reimbursing the City of Marshfield for what we used.

#### CTRI Award \$22,974.22.

We did receive the CTRI Award through the County. Richfield Wood project qualified so that is what we were awarded for. We would receive reimbursement in 2027. Richfield Drive would need to be separated as we would also do the parking lot at that time. Josh did not apply for LRIP.

#### **Snow Plowing**

The wing is back on the plow truck. We are still looking for somebody to snowplow. We do have a few potential candidates.

#### **Building Maintenance**

Josh ordered air fresheners for both bathrooms. He will check with Chris McDaniel regarding lights in the hall that need to be replaced. The air drop is leaking on the highway side so Chris will be capping it off.

# Adoption of Ordinance #14-Increasing Town Board to Additional Board Members

## **Marshfield Ambulance Contract**

Chris Christiansen made a motion to approve a tax collection bond in the amount of the township tax apportionment from Wood County. Bob Tomkowiak 2nd the motion. Motion carried.
